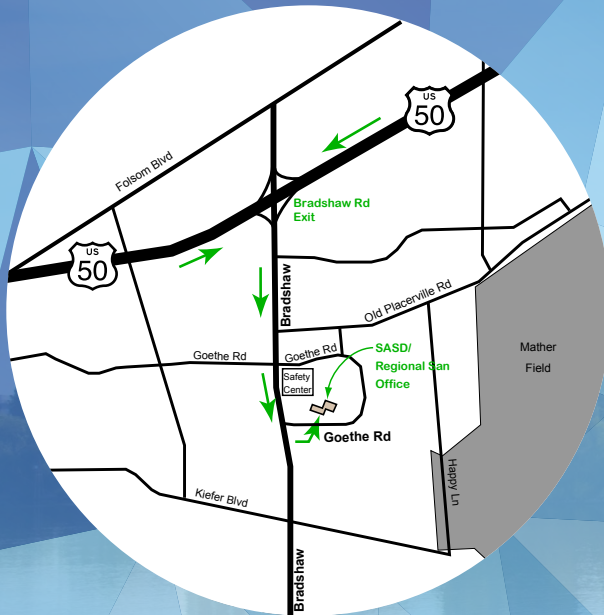

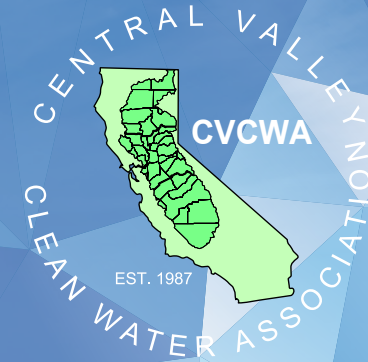
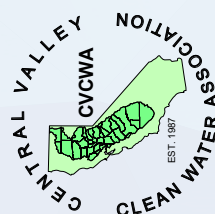
Directions
